PREFACE

The Internal Quality Assurance Cell (IQAC) of the institute launched a new initiative on 10th March 2021, to award the faculty and staff with "Certificate for Significant Contribution" based on their involvement in various activities that were exemplary for quality enhancement.

To commemorate the 65th anniversary of the institute, in year 2022, this initiative was further expanded beyond MITS boundaries, by launching a prestigious award to be conferred every year at MITS, to honor the esteemed memory of the **Late H.H. Rajmata Scindia of Gwalior**, who was not only the Chairperson of the Board of Governors, MITS for the longest period of 40 years from 1961 to 2001, but is also revered in this region for her empathy towards the masses. She was always very active publically and was a co-founder of the Bharatiya Janata Party. Under her loving, liberal and permissive patronage the institute grew in size, structure and stature, and has been mentoring globally successful, competent technocrats in every field of engineering.

The institute presently offers undergraduate degrees in 17 engineering & technology disciplines, post graduate degree in 10 specializations and Ph.D programme in 9 disciplines.

OBJECTIVES

- To enhance societal awareness about women issues
- To motivate society to strengthen the existing Government initiatives, schemes and policies for women
- To sensitize people about strengthening the position of women in the society
- To emphasize commitment of the institute towards establishing Gender Equity
- To inspire and motivate individuals & institutions to follow the awardees

ELIGIBILITY CRITERIA FOR NOMINATION

- —The award shall be open to all individuals and institutions working in Madhya Pradesh.
- —In case of individual category, the awardee must be at least 25 years of age on the last date of receipt of nomination.
- —Person or persons presently associated with MITS, Gwalior in any manner, cannot be the contenders for these awards.
- —If the applicant is an institution, it should have worked in the relevant field for at least 5 years.
- —The applicant should not be a recipient of the same award earlier.
- —The **नारी शक्ति सम्मान** will be awarded for outstanding work, preferably in exceptional circumstances, to individual women/social organizations/groups/NGOs etc. doing commendable work for economic and social empowerment of women; outstanding work for reducing the gender gap/sensitizing the society about gender equity/who have made a significant difference to the cause of women/and similar other contributions falling under the proposed umbrella may be considered for this award.
- —The नारी शक्ति सम्मान can be awarded to those who encouraged women to participate in

decision making roles; encouraged women's skill development in traditional and non-traditional sectors; contributed for education of under privileged women, facilitated basic amenities for rural women; promoted women in non-traditional sectors, etc.

MODE OF CALLING THE NOMINATIONS

- The information about the award, the eligibility criterion, application formats, important timelines etc. will be disseminated and widely publicized through the institute website, print media and all social media platforms.
- —Nominations will also be invited from prestigious social organizations and public/private bodies.
- —The nominations received will be scrutinized, summarized and short listed by an institutional committee constituted by the competent authority.
- The criteria for selection will be, the extent of contribution in the form of (i) Jurisdiction covered (local, state, national, international) (ii) Approximate number of persons benefitted (iii) Accolades or achievement (iv) years active/experience of the contenders in the particular field (v) similar other factors as may be deemed fit by the committee
- All the nominations along with the shortlisted cases will be put before the Jury for final decision.

CONSTITUTION OF THE JURY

- i. H.H. Priydarshini Raje Scindia, Chairperson
- ii. One member from the BoG, MITS, Gwalior (Nominated by the Chairman, BoG)
- iii. One member from education not below the rank of Director/ Vice chancellor (Nominated by the Chairman BoG or by member BoG authored by the Chairman)
- iv. One prominent local personality representing society/ social/ health organizations/ administration etc. (Nominated by the Chairman BoG or by member BoG authorized by the Chairman)
- v. One institute representative not below the rank of Professor (Nominated by the Director)
- vi. The Jury may at its discretion also consider individuals other than those recommended by the institutions/Organizations/M.P. Government /ministries etc.
- vii. The Jury reserves the right to reject any entry.

PRESENTATION OF AWARD

- —The recipients of the "स्वर्गीय राजमाता विजयाराजे सिंधिया नारी शक्ति सम्मान" shall be declared every year in the last week of February.
- —The Award shall consist of cash and medallion.
- —The last date for sending the nomination form (downloaded from the institute website www.mitsgwalior.in) along with supporting documents/annexures, by speed post or hand delivery to the following address is 14th February 2023.
- The envelope must mention the name of the award for which nomination is being sent, in bold.
