# **Application Procedure & Important Guidelines**

- Eligible Candidates are required to submit the application form in prescribed format as per the schedule. Candidates are required to pay application fee of Rs. 1000/- for General/OBC candidates and Rs.500/-for SC/ST candidate through DD in favour of Director, Madhav Institute of Technology & Science, (Deemed University), Gwalior.
- Candidates are advised to check the eligibility for the program in which admission is sought before filling the application form.
- The candidate, who has appeared this year in the qualifying examinations, will also be considered for admission. However, if selected for admission, such candidate will be admitted provisionally, subject to condition that:
- (i)He/she shall submit the copy Mark sheet/Degree of the qualifying examination before registration for the programme.
- (ii)He/ she shall meet the eligibility criteria.
- The merit list and waiting lists shall be placed on MITS-DU's web site <u>www.mitsgwalior.in</u>.
- No TA/DA will be admissible for attending written test/interview (if applicable).
- No separate call letter will be issued from the Institute for Written test / interview.
- The admissions and Ph.D. Degree shall be as per MITS-DU ordinance for Ph.D.Programme.
- For fees details, please visit the website of the MITS-DU <u>www.mitsgwalior.in</u>.
- List of candidates selected for admission will be required to deposit fee through online mode and complete the formalities for registration in the MITS-DU as per schedule.
- If the candidate does not deposit the fee through On-Line mode within stipulated time, his/her candidature shall be considered cancelled and the eligible candidates from the waiting list will be offered admission against vacant seats as per the schedule.

#### **Merit-Based Selection Process**

First, admission shall be given to candidate who qualify for fellowship/scholarship in **UGC-NET/UGC-CSIR NET/GATE/ CAT/MAT/ CMAT/GMAT/ CEED** and similar National level tests and performance in the Technical interview to be conducted by MITS-DU.

If Seats remains vacant then the admission will be done on the basis of PPQE/written test and technical interview, etc. as decided by the competent authority of the MITS-DU.

**vi.** Provided that for the selection of candidates based on the weightage of 70 % for the qualifying test (UGC-NET/UGC-CSIR NET/GATE/CEED/PPQE or similar National level tests) and 30 % for the performance in the interview/viva-voce/ presentation shall be given.

**vii.** Mere short-listing of an applicant does not confirm admission to PhD programme. The admission shall be solely based upon the performance of individuals during "presentation and interview" and availability of the Supervisor in the proposed area of research.

**3.2** All the applied/ selected candidates will be governed by the rules and regulations of the PhD Ordinance as applicable from time to time. Any amendments made in the ordinance and applicable to the existing candidates shall be binding.

3.3PhD Pre-Qualifying Exam (PPQE): The candidates who have not qualified UGC-NET/UGC-CSIR NET/GATE/CEED or similar National level tests shall be required to appear in a PPQE organized by the MITS-DU. The PPQE may be of Multiple-Choice Question (MCQ) Mode. The syllabus shall consist of questions based research/ on analytical/comprehension/quantitative aptitude and subject specific. The syllabus for the written test will be the same as the latest GATE/NET syllabus in the related branch of Engineering/ Technology/ Science/ Humanities. A candidate must qualify the PPQE as per norms to be eligible for the interview.

**3.4Interview:** The eligible candidates who have qualified the PPQE or have a valid UGC-NET/UGC-CSIR NET/GATE/CEED or similar National level tests score shall be called for the interview. At the time of interview, candidates may be asked to discuss their research interest/area in the form of a presentation.

**3.5PhD Programme Part-time:**In addition to fulfilling the criteria mentioned in Clause 3.1 to 3.4, the candidates seeking admission in Part-Time PhD programme should be, professionally employed as engineers or scientists in public sector undertakings or government departments or national level R&D organization/national laboratories, industry, having sufficient facilities to carry out research at their place.

OR

Regular Faculty of reputed Institutions/Universities/colleges.

Part-Time candidates are required to submit a "**No Objection Certificate**" on a proper letterhead from the appropriate authority in the organization clearly stating the following:

i. The candidate is permitted to pursue studies on a part time basis and will complete the residential requirement as per MITS-

	DU norms.
	ii. That his/her official duties permit him/her to devote sufficient
	time for research.
	iii. Sufficient research facilities are available at the candidate's
	place of work.
4. Admission	Candidates whose selection is recommended by the Interview Board
	and approved by the Vice-Chancellor shall be admitted and advised to
	deposit prescribed fees. For all purposes, the date of registration of a
	Research Scholar shall be the date on which he/she has deposited a fee
	in the MITS-DU.

# **Financial Assistance and other support**

- The eligible deserving **Ph.D. Research Scholars** may get the fellowship under **Research Assistantship scheme of MITS-DU** as per prescribed selection process available on MITS DU website.
- The **Research Assistants** will be eligible for Innovative Research Scheme (IRS) of the MITS-DU with co applicant as regular faculty of the Institute.
