- Items and Specifications:** The items supplied must strictly conform to the **specifications mentioned in the NIQ**. Any deviation from the specified requirements must be **clearly indicated** in the quotation; otherwise, it shall be presumed that the quoted items fully comply with the required specifications.
- Delivery Schedule:** The supply shall be completed within 30 days from the date of issuance of the Purchase Order, unless otherwise specified. Delay in supply may result in **penalty, cancellation of the order, or both**, at the discretion of the Institute.
