## Brief overview of the workshop

The **mandatory workshop on Indian Constitution and Traditional Knowledge** aimed to explore the legal and constitutional frameworks surrounding traditional knowledge systems in India. The primary objective was to understand how the Indian Constitution protects and preserves traditional knowledge, culture, and practices while addressing challenges posed by modern legal systems.

The **Department of Artificial Intelligence**, in collaboration with the **Department of Chemical Engineering**, organized a two-day workshop on "Indian Constitution and Traditional Knowledge" on the **5th and 6th of October 2024** in the institute's colloquium.

A total of **327 students registered** for the program, of which **317 attended** the workshop. **Twelve students were absent** or failed the quiz conducted during the event.

### Workshop Objectives

- To introduce participants to the constitutional provisions relevant to the protection of traditional knowledge in India.
- To explore the relationship between traditional knowledge and intellectual property rights, focusing on legal frameworks.
- To discuss real-world case studies highlighting the application of constitutional principles in protecting cultural heritage.
- To examine the role of modern technology, such as AI, and its legal implications in the context of privacy and traditional knowledge protection.

### Workshop outcomes

Participants will be able to

- identify the constitutional provisions safeguarding traditional knowledge.
- understand the link between traditional knowledge and intellectual property rights.
- apply constitutional principles to real-life case studies on cultural preservation.
- analyze the impact of AI and privacy laws on the protection of traditional knowledge.

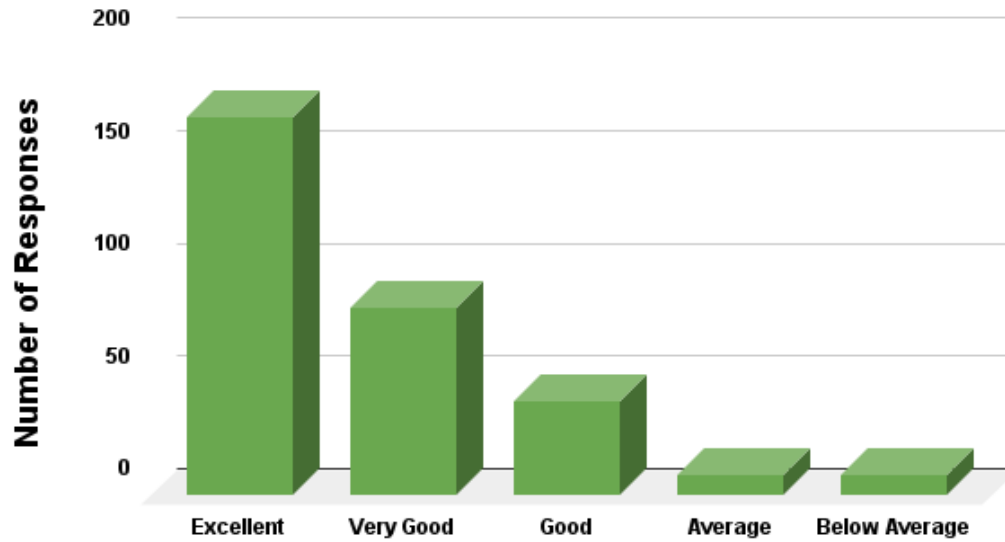

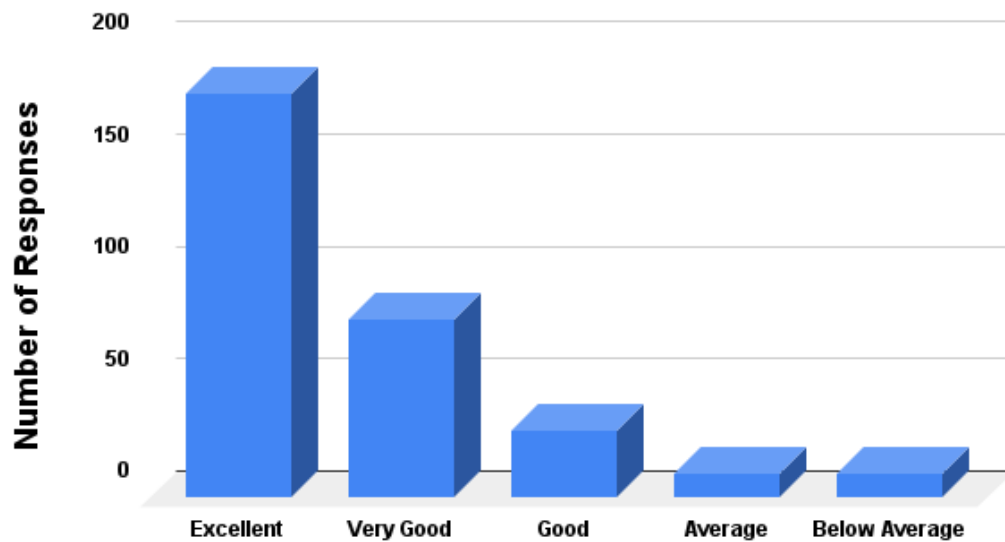

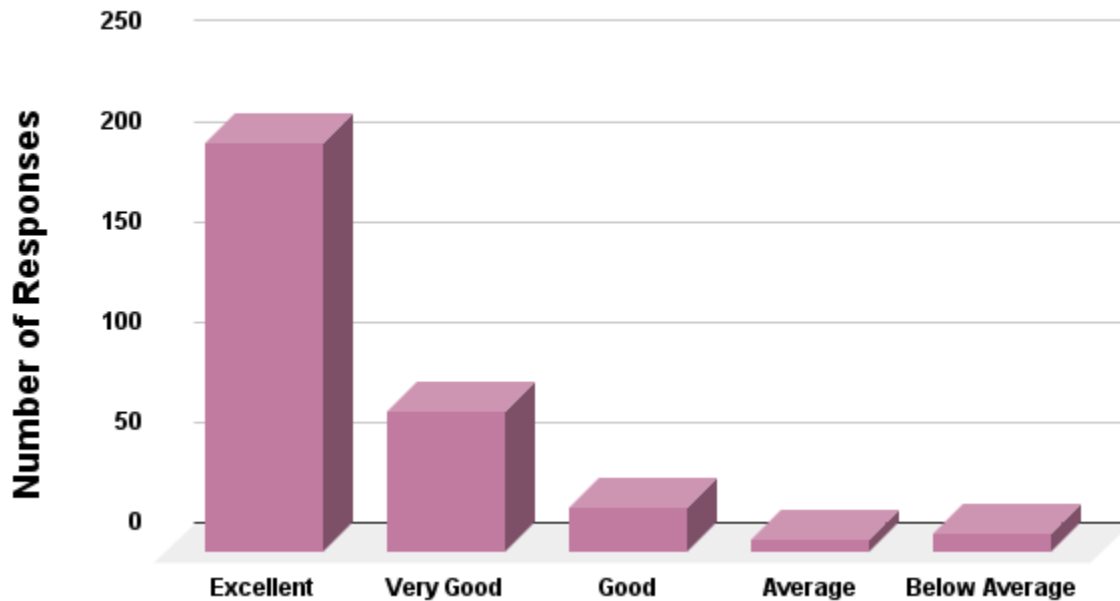
