# 22.3 Procedure for Challenge/Persuasion

- 22.3.1 A candidate whose revaluation result has been declared may apply for challenge /persuasion for a maximum of two of his/her answer books in the prescribed pro-forma/ online within a week after the declaration of revaluation result. After receiving the application for persuasion, the scanned answer scripts will be made available on the student's log-in ID on University web portal for submitting his claim.
- 22.3.2 No challenge/ persuasion shall be allowed in case of answer scripts of practical examinations /mid semester examinations / internal assessments/ field works and sessional works.
- 22.3.3 In order to apply for challenge/persuasion a student has to present his case supported by relevant documents through email to Controller Examination office pertaining to his /her justifying the answers for which he/she wishes to claim. The relevant documents should be in support of their answers. A candidate will not appear in person for this purpose.
- 22.3.4 If the marks awarded during persuasion/challenge in the paper/subject vary from the marks given by the original examiner by more than 10 (Ten) percent of the maximum marks in the paper/subject then only in such cases the candidate's result will be revised. The same rule will apply as in case of revaluation
